The goal is 180 days from end of course to initiate NREMT testing (Nov)

REMS hosted a CEU scanner training with 17 in attendance

Fall Programs

Staff is working to announce fall programs. Course approvals have been completed and announcements should be going out soon as well as placed on our website.

CTS

The protocol for transfer of care to a lower level is being written and will be presented to the medical direction committee. Linda will contact the REMS webmaster, Mark Crnarich concerning online polls for both the protocol and ALS release committees. The 12 lead protocol is already in the current protocol book. Greg Leitz will be contacted for his training program. The Prethrombolytic check list was developed in conjunction with the MWH Stroke team. The Medical Direction has approved the check list. It now needs approval from the G & T committee. Motion by Mark to approve, seconded by Pat, motion passed. REMS will work on putting the Google groups for the protocol and ALS release committees back on the list serve so providers can sign up and comment.

Training Department Report

FA09 Intermediate and Paramedic Courses

Both classes have been completed and students are finalizing their field internship requirements.

From the Intermediate class – 5 have completed both written and practical testing for NREMT-I; 1 has completed the written testing but not the practical; 1 has attempted written testing. Two students have not yet completed the course requirements to be eligible for NREMT. The balance (8) are in the process with NREMT but have not yet tested.

From the Paramedic class – 1 has completed both written and practical testing for NREMT-P; 4 have yet to complete the course requirements to be eligible for NREMT. The balance (5) are in the process with NREMT but have not yet tested.

Virginia Paramedic Accreditation

The Paramedic follow up site visit for our re-accreditation was conducted by OEMS and we are now accredited through December 31, 2012. We must attain national accreditation through CoAEMSP by January 1, 2013. This process will be started in the next 30-60 days as the application is upwards of 70 pages and once submitted and approved it can take up to 6-8 months for the site visit to occur and the results are not available for 6-8 months after the site visit.

FA10 ALS Certification Programs

The FA10 Intermediate and Paramedic classes start October 26. There are 22 students confirmed in the Intermediate class and 9 students in the Paramedic class. Course approvals were submitted and training funds were also approved as submitted.

Sub-Committee Reports:

Protocol Subcommittee: The committee last met on December 21, 2010. Keith Moore had met with the Medical Direction Committee at their December meeting and gave the following report: Mark 1 Kits/WMD-the Medical Direction Committee supported using the protocol that was created for the BSJ last summer and adapting it for our new regional protocols. Both Crush Syndrome Protocol and Therapeutic Hypothermia protocol were reviewed and discussed by the Medical Direction Committee, with some reservations in supporting as presented. Keith and Brian will write a protocol and take it back to the next committee meeting. The REMS Stroke Triage Plan Committee will meet in January to develop a draft Stroke Triage Plan for the region that will incorporate the Stroke Checklist. Dr Roberts, OMD of Stafford County has a protocol for Hemostatic agents which he will forward to Keith Moore for the Protocol Committee to review.

ALS Release Subcommittee: Discussion ensued regarding a request from Doug Found to consider conducting an ALS Preceptor Training Course to support the need for Enhanced level preceptors. Will seek to schedule one in February, 2011. Keith Moore also talked to the Medical Direction Committee about creating a release program for those experienced providers that are RN's and have just completed a paramedic program. The unanimous position of the Medical Direction Committee was that, due to the widely varying background of RNs, those wishing to be released without completing a full ALS precepting process will demonstrate proficiency in multiple core areas (to be determined, such as adult and pediatric advanced airway management, med math calculations, megacode, etc.). This should be completed under the supervision of an experienced, Paramedic preceptor as assigned by the ALS Release Subcommittee. The reason for this provision is due to the candidates request to bypass the release process and just be tested on their KSAs. This will be sent

back to the ALS Release Subcommittee to create a draft program based on the OMD's input and then it will be presented to the OMD Committee and REMS Board for final approval and implementation.

Unfinished Business: None

New Business:

<u>Skills Drills Forms</u>: Greg Leitz asked if they could use the State OEMS forms to evaluate the EMT-B providers in the regional skills drills as opposed to using the NREMT forms. He stated they consolidate some of the skills into just one form and the state forms are more user friendly. Motion was made by Wayne Green and seconded by John Brandrup to recommend using the state forms. Motion carried.

ALS Preceptor Tests: Linda Harris asked for some guidance on the retest policy for ALS preceptor candidates. There seems to be no current policy on how long the provider has to wait between the primary test and the retest, as well as what to do if the provider fails the retest. The general consensus was the provider will need to wait a minimum of 10 days between the primary test and the retest and if they fail the retest both their supervisor and the OMD will be notified. They can retest again no sooner than 30 days and after a letter has been received from the supervisor that remediation on the protocols was done. If the provider fails the test for the third time they will need to meet with their OMD. This policy will need to go to the REMS Board for final approval and implementation. Motion was made by Greg Leitz, seconded by John Brandrup, and carried to send this to the ALS Release Subcommittee to develop a draft policy.
