The King George County Department of Fire, Rescue & Emergency Services is seeking qualified applicants to fill Full-Time, twenty-four hour (24/7) and Part-Time Firefighter/EMT vacancies.

This position will be required to work rotating 24 hour shifts at a variety of station locations throughout the County. This position will be required to work days, nights, weekends, and holidays while preparing for and responding to emergency calls from the public.

PREREQUISITIES:

- Emergency Vehicle Operators Course (EVOC 1, 2, 3)
- Certified as an Emergency Medical Technician – Basic or Above
- Current CPR Certification (BLS Healthcare Professional or equivalent)
- Firefighter II (ProBoard) – *Non Certified or Non-ProBoard Firefighter Level II applicants may apply for consideration, but would start at a reduced salary and be required to obtain Virginia Department of Fire Programs Firefighter II or ProBoard Firefighter II or be required to attend a full-time Fire Academy within 1 year of hire.*

***Preference given for Fire / EMS work experience, driver pump operator, vehicle rescue, instructor certifications, and/or graduation from an approved Fire Academy.**
