The King George County Department of Fire, Rescue & Emergency Services is seeking qualified applicants to fill the position of Lieutenant – (Assistant Training Officer / Recruitment & Retention) assigned to the Training Division. Duties will include a variety of fire, rescue, and EMS training instruction along with recruitment & retention duties, orientation of new personnel, mentoring, precepting, data collection, program development, etc.

This position will work a 40 hour work week and must be flexible to work nights, weekends, and holidays as needed. This position may need to fill in with daily operations as needed.
