HB 1344 Flashing lights on motor vehicles; "move over" law.

Chief patron: Rasoul

An Act to amend and reenact § 46.2-1025 of the Code of Virginia, relating to vehicles equipped with flashing amber, purple, or green warning lights.

Summary as passed House:

Flashing lights on motor vehicles; "move over" law. Allows vehicles that assist with the management of roadside and traffic incidents or that perform traffic management services along public highways to be equipped with flashing, blinking, or alternating amber warning lights. Virginia's "move over" law applies to such vehicles. A violation of this provision is punishable as a traffic infraction.

HB 1391 Interstate Health Care Compact; established.

Chief patron: Albo

A BILL to amend the Code of Virginia by adding in Title 32.1 a chapter numbered 17, consisting of a section numbered 32.1-370, relating to the establishment of the Interstate Health Care Compact.

Summary as introduced:

Interstate Health Care Compact established. Creates the Interstate Health Care Compact to (i) secure the right of the member states to regulate health care in their respective states pursuant to the compact and to suspend the operation of conflicting federal laws, rules, regulations, and orders within their states and (ii) secure federal funding for member states that choose to invoke their authority under the compact. The bill also creates the Interstate Advisory Health Care Commission to study issues related to the regulation of health care that are of particular concern to the member states and make nonbinding recommendations related to the regulation of health care to the member states for consideration by the legislatures of the member states. The bill provides that the compact becomes effective within a member state upon adoption of the compact by at least two member states and consent of the United States Congress.

An Act to amend the Code of Virginia by adding a section numbered 46.2-203.2, relating to the Department of Motor Vehicles; emergency contact program.

Summary as introduced:

Department of Motor Vehicles; emergency contact program. Provides that DMV may establish an emergency contact program to allow customers to give DMV the name of an emergency contact person and related emergency contact information, which the customer may update or delete electronically at any time, to be kept in the customer's DMV record and made available to law-enforcement officers in emergency situations. The bill has a delayed effective date of January 1, 2016.

An Act to amend the Code of Virginia by adding in Article 1 of Chapter 5 of Title 32.1 a section numbered 32.1-137.03, relating to discharge planning; designation of individual to provide care.

Hospital discharge procedures; designation of individual to receive information and instructions. Requires hospitals to provide each patient admitted as an inpatient or his legal guardian the opportunity to designate an individual who will care for or assist the patient in his residence following discharge from the hospital and to whom the hospital shall provide information regarding the patient's discharge plan and any follow-up care, treatment, and services that the patient may require.

A BILL to amend the Code of Virginia by adding sections numbered 54.1-2403.4 and 54.1-2506.02, relating to regulation of health care providers; prohibited acts; penalties.

Regulation of health care providers; prohibited acts; penalties. Provides that any person who is licensed, registered, certified, or otherwise subject to the oversight of a health regulatory board who knowingly or intentionally makes any false statement or includes any false information in a patient's medical record is guilty of a Class 1 misdemeanor and that any individual who knowingly or intentionally makes a false statement or provides false information related to the

subject of an investigation to investigative personnel of the Department of Health Professions engaged in the investigation of a complaint is guilty of a Class 1 misdemeanor.

HB 1441 Child abuse or neglect, suspected; person required to report, training program required.

Chief patron: Bell, Richard P.

A BILL to amend and reenact § 63.2-1509 of the Code of Virginia, relating to persons required to report suspected child abuse or neglect; training.

15100910D

Summary as introduced:

Persons required to report suspected child abuse or neglect; training. Requires all mandated reporters of suspected child abuse or neglect to complete a training program for the recognition and reporting of suspected child abuse or neglect within six months of employment, licensure, certification, registration, approval to serve as a mediator, or approval to serve as a court-appointed special advocate and at least once every five years thereafter. The bill also requires all employers of mandated reporters, boards that license, certify, or register mandated reporters, courts that refer cases for mediation, and courts that appoint court-appointed special advocates to provide mandated reporters with a written explanation of these requirements within one month of such persons becoming a mandated reporter. Current mandated reporters are given one year to obtain the required training.

HB 1458 Naloxone or other opioid antagonist; pharmacist may dispense in cases of opiate overdose.

Chief patron: O'Bannon

A BILL to amend and reenact §§ 8.01-225 and 54.1-3408 of the Code of Virginia, relating to prescription, distribution, and administration of naloxone or other opioid antagonist.

Summary as passed House:

Naloxone; administration in cases of opiate overdose. Provides that a pharmacist may dispense naloxone or other opioid antagonist used for overdose reversal pursuant to an oral, written, or standing order in accordance with protocols developed by the Board of Pharmacy in consultation with the Board of Medicine and the Department of Health, that a person may possess and administer naloxone or other opioid antagonist used for overdose reversal to a person who is believed to be experiencing or about to experience a life-threatening opiate overdose, and that firefighters and law-enforcement officers who have completed a training program may possess and administer naloxone. The bill also provides that a person who in good faith prescribes, dispenses or administers naloxone or other opioid antagonist used for overdose reversal in an emergency to an individual who is believed to be experiencing or about to experience a life-threatening opioid overdose shall not be liable for any civil damages for ordinary negligence in acts or omissions resulting from the rendering of such treatment if acting in accordance with the provisions of § 54.1-3408 or in his role as a member of an emergency medical services agency.

HB 1500 Overdoses; definition, safe reporting by individual.

Chief patron: Carr

A BILL to amend the Code of Virginia by adding a section numbered 18.2-251.03, relating to safe reporting of overdoses.

15100050D

Summary as passed House:

Safe reporting of overdoses. Establishes an affirmative defense to prosecution of an individual for (i) simple possession of a controlled substance, marijuana, or controlled paraphernalia; (ii) intoxication in public; or (iii) the unlawful purchase, possession, or consumption of alcohol if such individual sought or obtained emergency medical attention for himself or for another individual because of a drug- or alcohol-related overdose and if the evidence for the charge was obtained as a result of the individual seeking or obtaining emergency medical attention. The bill provides that the affirmative defense may only be invoked by an individual who (a) remains at the scene of the overdose or at any location to which he is transported for emergency medical attention until a law-enforcement officer responds to the report of an overdose, (b) identifies himself to the responding law-enforcement officer, and (c) cooperates, upon request, with any criminal investigation reasonably related to the drug or alcohol that resulted in the overdose. No individual may assert this affirmative defense if the emergency medical attention sought or obtained was during the execution of a search warrant or during the conduct of a lawful search or a lawful arrest.

A BILL to amend and reenact §§ 19.2-389, 19.2-392.02, 63.2-100, 63.2-603, 63.2-901.1, 63.2-1506, 63.2-1515, 63.2-1702, 63.2-1708, 63.2-1720 through 63.2-1726, 63.2-1809, and 63.2-1809.1 of the Code of Virginia, to amend the Code of Virginia by adding sections numbered 63.2-1720.1 and 63.2-1721.1 and by adding in Article 2 of Chapter 18 of Title 63.2 a section numbered 63.2-1820, and to repeal § 63.2-1704 of the Code of Virginia, relating to regulation of child day programs, child day centers, and family day homes.

Regulation of child welfare agencies; national criminal history record checks. Establishes a national criminal history record check requirement for licensure as a child welfare agency, for approval as a family day home by a family day system, for approval as a foster or adoptive parent; for employment or to volunteer at a child welfare agency or family day home; and for all adults residing in a home in which a family day home is operated. The bill requires all family day homes that provide care for one or more children for compensation to be licensed by the Department of Social Services. Currently, only family day homes providing care for six or more children must be licensed. The bill also provides that, for the purposes of determining the

number of children receiving care, the provider's own children and any children residing in the home shall be counted.

HB 1558 Adult fatality review teams, local and regional; created, penalty.

Chief patron: Rust

An Act to amend and reenact §§ 2.2-3705.5, 2.2-3711, 2.2-4002, 32.1-283.5, and 63.2-1606 of the Code of Virginia and to amend the Code of Virginia by adding a section numbered 32.1-283.6, relating to local and regional adult fatality review teams; penalty.

Summary as passed House:

Local and regional adult fatality review teams; penalty. Allows for the creation of local or regional adult fatality review teams upon the initiative of any local or regional law-enforcement agency, department of social services, emergency medical services agency, attorney for the Commonwealth's office, or community services board. The bill provides that such teams may review the death of any person age 60 years or older, or any adult age 18 years or older who is incapacitated, who resides in the Commonwealth and who is in need of temporary or emergency protective services (i) who was the subject of an adult protective services or law-enforcement investigation; (ii) whose death was due to abuse, neglect, or exploitation or acts suggesting abuse, neglect, or exploitation; or (iii) whose death came under the jurisdiction of or was investigated by the Office of the Chief Medical Examiner as occurring in any suspicious, unusual, or unnatural manner. Allows a practitioner to prescribe naloxone to a patient for administration to a person other than the patient when the patient believes the person is experiencing or is about to experience a life-threatening opiate overdose and allows a person to possess naloxone and administer naloxone to a person experiencing or about to experience a life-threatening opiate overdose. The bill provides that under such circumstances (i) a person who administers naloxone to another person shall not be liable for civil damages and (ii) a prescriber shall not be civilly or criminally liable for injuries resulting from the prescription of naloxone to a patient for administration to another person. The bill also allows emergency medical services personnel and other first responders to possess and administer naloxone pursuant to a written order or standing protocol, and the bill provides that first responders and emergency medical services personnel who administer naloxone pursuant to a written order or standing protocol shall not be civilly or criminally liable for injuries resulting from the administration of naloxone.
