Registration is on the REMS Website. There is no charge to the provider. A big thank you to Maurice Moody for sharing this information with his agency. A number have been attending. Maurice stated he has received positive feed-back from those attending on the quality and content of the classes and instructors. We will attempt to do these classes again in the fall.

Any provider who is looking for Category 1 (NCCR) hours be careful with who is coordinating the class you are taking. Category 1 hours (NCCR) for EMR or EMT can only be obtained in a class that is coordinated by an Education Coordinator. If the course coordinator is an ALS Coordinator any EMR or EMT will get category 2 hours (LCCR/ICCR). For any advanced provider – AEMT, Intermediate or Paramedic- you can get Category 1 hours (NCCR) in any class coordinated by a ALS Coordinator. We had an EMT come to our office because some hours for a few classes she attended showed up as LCCR/ICCR and she thought they should be NCCR. These classes had an ALS Coordinator as the course coordinator.

How do you want us to craft the coordination of this training? ODEMSA has developed a coalition of all individuals providing this training. When a request comes in for the training it is routed though the coalition to figure out who is available to teach. They have also implemented a train the trainer program for schools & businesses. Their trainers will go into teach a few individuals the train the trainer and then they in turn will teach a few others. Then moving on to make sure all individuals have the training. This will be brought to the next meeting for discussion.

FICEMS – Update on Opioid Crisis – June 2018- Continuing to be an issue region wide and state wide. Our Protocol Committee under the Medical Direction Committee is in the process of updating the Scope to following the State. The incidences are continuing to rise – unsure if it is that prevalence of Narcan is making people more risky or it is just rising.

FICEMS – Safety, Education and Workforce Committee- NIOSH & NHTSA is working on a project tracking nonfatal emergency department treated injuries among EMS workers. There is a policy in place for fire fighters but not EMS providers. Another part is medical errors and threats to patient safety which can include fatigue risk management, safe transportation of children. EMSC at state level has purchased \$65,000 worth of pediatric restraint equipment and the current and next RASF grant cycle will be a priority for pediatric restraint. How are we going promote this or target here? How do we want to address this?

New Business

EMS Agenda for the Future 2050- Per Wayne this is to be discussed as a regular recurring topic. He wants annual committee goals around a distinct movement towards the future of EMS. Something that we can lay as a foundation now and build upon in the coming years. There are 6 goals and Wayne would like for this committee to take 2 per meeting and discuss what we would see our system to look like in the future. Lay a framework to move in this direction.

A provider with Fredericksburg Rescue Squad is requesting an Out of Region release. He did submit paperwork that he was starting the precepting process in the REMS Region in August of 2018. He is currently employed by Physicians Transport Service in Northern Virginia. His supervisor for that agency sent to the REMS council information on his release with that agency. He precepted for approximately 6 weeks with 15 shifts and 65 ALS patients. This information was received by REMS in October 2018. In March 2019 the provider asked for an out of region release claiming he was not having success in running shifts with local preceptors. This was sent to Lennie as the chair of the ALS Release Committee and she stated that it was not comparable to our release program since he precepted in a transport agency. Most of his contacts were most probably inter-facility transports rather than 911 calls. And he would need to complete a full 52-call precepting period in our region. He then sent another email asking to complete only 10 contacts and then take the protocol test. Again, this was sent to the chair and Lennie asked to bring it to the Committee. After much discussion the motion was made and seconded to deny the request. The motion was approved by the committee. Committee member Victor Podbielski, who is the training officer for the Fredericksburg Fire Department, said he would take this provider's information to the OMD for the City of Fredericksburg for a final ruling. He would also investigate to see if the provider has completed any patient contacts during the time he has been precepting. He will report back to the committee at the next meeting.

Our Protocol Committee under the Medical Direction Committee is in the process of updating the Scope to following the State. The incidences are continuing to rise – unsure if it is the prevalence of Narcan that is causing people to take more risks, or is it the rising use of opioids.

FICEMS – Safety, Education and Workforce Committee - NIOSH and NHTSA are working on a project tracking nonfatal emergency department treated injuries among EMS workers. There is a policy in place for fire fighters, but not EMS providers. Another part is medical errors and threats to patient safety which can include fatigue risk management and safe transportation of children. EMSC at the state level has purchased \$65,000 worth of pediatric restraint equipment and the current and next RASF grant cycle will be a priority for pediatric restraint. How are we going promote this or target here? How do we want to address this? This will be tabled until the next meeting

EMS Agenda for the Future 2050- Per Wayne this is to be discussed as a regular recurring topic. He wants annual committee goals around a distinct movement towards the future of EMS. Something that we can lay as a foundation now and build upon in the coming years. This will be tabled until the next meeting

John Brandrup sent a report on the status of the cell phone app being used in ODEMSA. He has had conversations with those that have worked on this application he believes it would work well for our providers.. He now needs to meet with ODEMSA to obtain training on how to program the app for use in our region. More information will be presented at the June meeting.
