Call to Order	Meeting called to order at 3:00 p.m. by Chairman, Lori Knowles and welcomed all members with introductions.	
Approval of Minutes	The minutes of the June 6, 2018 meeting were approved as presented.	
Virginia Stroke Care Advisory Group	Greg Leitz has been named to represent the REMS Council region on this new state level advisory group. Held first quarterly meeting August 10 th . Greg was in attendance by phone and difficult to follow the meeting. Minutes were provided to the group which included reports from hospitals and EMS council regions on stroke initiatives being conducted around the state. MWHC shared that at the last VSSTF state meeting, Patrick Wiggins, Health Systems Intervention Coordinator, Virginia Department of Health, facilitated an open discussion to propose ideas for quality improvement and focus areas within the recent stroke legislation. Several ideas presented include: AHA Get With The Guidelines, Get Ahead of Stroke, the need for a centralized database, explore data and prioritize based on gaps, focus on underserved areas, EMS data, and Hospital-EMS collaboration for quality improvement. Feedback from VSSTF meetings will be shared with the VA Stroke Care Quality Improvement Advisory Group. Next meeting scheduled for October 2018.	
Virginia Stroke Systems Task Force (VSSTF)	Last meeting was held July 20, 2018 in Chesterfield, Virginia with strong presence from our region. Mission and goals for the year were discussed. A presentation from the PEMS EMS region on LVO stroke assessments was presented and discussion on the new Get with the Guidelines (GWTG) EMS Special Initiative for stroke data collection. MWHC shared they have begun to report EMS data in GWTG under the new initiative. Pulling data from EMS reports on stroke patients transported to MWH who received tPA or intervention retrospectively. Presented results for April & May 2018 to committee. The four data elements MWH Stroke Center will be tracking include: EMS on scene time, documentation of last known well, stroke assessment performed and documented, and door in door out times for patients being transferred for interventional therapy. Mark Crnarich is also creating regional stroke data reports through council's access to ImageTrend data. Will work with MWHC and committee to ensure we are capturing meaningful data for the EMS agencies and stroke performance improvement goals.

Large push to take patients to endovascular facilities, which we do not have but are doing a good job with triaging in the field. Also big push is to make stroke centers have Levels similar to the trauma center levels. They also are the ones who created the Stroke App which the provider will enter the criteria for the different stroke scales and as soon as LVO criteria is met, it will alert them to take patient to an endovascular capable facility. Greg is happy to report that the REMS Region and the Commonwealth as a whole is way ahead of the country in stroke scale.
